CHESTER TIMES – March 21, 1914 – DELCO – REALTY – ART GALLERY PLANS READY – Future Home of the Deshong Costly Paintings to be Built in the Near Future

The people of this city are deeply interested in the erection of the new art gallery, which is to be the future home of the valuable collection of paintings and bric-a-brac which were willed to the people by the late Alfred O. Deshong in connection with the Deshong Memorial Park. The trustees under his will, Clarence Deshong, brother; Judge William B. Broomall and James A. G. Campbell, President of the Delaware County Trust Company, have been earnestly at work trying to get matters in shape so that the contract for this building could be let early this spring. The news was given out today that Brazer Arbab, the New York architects, have completed the plans and will ask bids for the work have days. This will be good news to the citizens generally, for with the starting of work on the building, it is expected that other work in connection with beautifying the and or Edgmont Avenue between Ninth and Eleventh streets, will be started. The trustees have a number of bids from leading landscape artists over the country, for the laying out of the walks, the driveways, the tennis courts, the baseball grounds, the swimming poils and the many other things which will be provided for the amusement and pleasure of the general public. The new art gallery which will cost between \$50,000 and \$70,000 will be located on the knoll at Eleventh Street and Edgmont Avenue and will have a most sommanding view. It will be constructed of stone and the finest Italian marble and will have dimension of 60 by 90 feet. It will be about forty feet high, and will contain steam heat and electric lights.

So far everything which has been purchased by the trustees for the Memorial Park have been secured from local dealers and it is the hope of all that the contract for the new art gallery will go to a local builder. This will be entirely satisfactory to the well-known gentlemen in whose ability to administer the estate, the late benefactor of the city had the utmost confidence.

LARGEST DEAL FOR WEEK – The largest deal in this city for the week was the sale of the Patterson Mills, property or Fifth and Penn Streets for the sum of \$85,000 which is considered a good omen for all the people of the city. An industry which has stood idle for eight years to start up and give work to upwards of 600 persons means much to not only the section of the city in which it is located but to all of the sections.

The news stores being erected by Samuel Lax on Edgmont Avenue below Third for Howard W. Marth, the First Ward grocery man are progressing and should be ready for occupancy in the early summer. These buildings will make a marked improvement to that section of the sity:

Mr. Berhard who recently went to live in the house of Mrs. Joseph Ladomus on East Fourth Street, has made a number of improvements to the property for the convenience of his family.

Ground has been broken for the new stores on West Third Street between the river and Dock Street and the work of completing these will be pushed along as rapidly as possible. This is a building operation which will cost about \$20,000 to complete and the owner, who is a Philadelphian, hopes to have the new stores and dwellings completed as soon as the weather will permit.

Builder J. Irvin Taylor has not started on his proposed new houses at Fifth and Penn streets, but will do so in a short time. There will be great need for the class of dwellings he will put up with the starting up of the Patterson Mills. One of the sure signs that there will be plenty of building this spring is the fact that the plumbers over the city have been asked to bid on a great deal of work, even more than last year at this time.

General William G. Price is asking bids for a new apartment house to be located on his land at Fifth and Edgmont Avenue and he hopes to start to build during the early spring so that the building will be ready for occupancy by fall.

With more than two hundred houses to go up at once; the erection of the Deshong Memorial art Gallery; the building of the new home for the Y. W. C. A.; the building of two handsome homes for the Messrs. Wetherill in the upper section of the city; and the great improvements contemplated by some industries about the city, there should be lack of work for the mechanics and laborers the coming summer.

IN THE WEST END – The west end is to have even a greater boom in the bailding line than last year which is saying a great deal. J. C. Taylor, the well-known lawyer is about ready to let the contract for a number of two story modern dwellings at Fourth and Engle Streets, and many other houses are being planned for early spring by local builders in that section of the city.

Plans are almost completed for two schools for the Borough of Darby. The architects will be ready to receive bids in a few days according to announcement. These buildings will be constructed of brick and will be up-to-date intevery way. One of them will be 90 by 24 by 70 feet and the other 30 by 70 feet both of which will be two stories high.

A new home is to be built in Haverford Yownship for Robert Meade Smith, Jr., of Philadelphia. The material will be stone and timber and it will be two and one half stories high, shingle roof with the heating and lighting reserved. Mantle Fielding is the architect and he will have the plans and specifications completed in a short time.

Bids will be asked the coming veek for the cost of the erection of the one story church at Llanerch to be built by St. Andrew's M. E. Church. It will be one story high, tin roof electric lighting.

A large number of well-known builders are figuring on the plans for the new church and school in the boogh of Darby to be built for Church of the Blessed Virgin of the Catholic Church
