DOINGS IN DARBY BOROUGH – This autumn will probably witness the erection of several fine residences in the borough of Darby. Plans for some of the dwellings are already prepared and the contracts for these are expected to be let in the near future.

Charles F. Eggleston has plans out for the erection of a handsome residence, office and garage at Second and Main Streets, on a part of the tract formerly the Damon property, for Dr. V. M. Reynolds. The plans have been prepared for the building by Architect H. M. . Mr. Eggleston contemplates the erection of three more houses of a high class, fronting on Main Street. The houses are to be two and a half stories high.

It is reported that there will be a three-story store and dwelling erected in Man. Street also, but the name of the builder of the same is withheld, as well as the except location.

- Dr. H. L. H. Dick has plans completed, and will in a few days give out the contract for the erection of a handsome dwelling on Ninth Street, adjoining the ne ecently purchased, which will be remodeled.

TRANSACTIONS IN COUNTY – John C. Merion of the Land Title and Trust building, Philadelphia, will soon have plans repared for a new two-and-one-half-story brick, plaster and frame building at Wayne. He will build this for sale purposes at a cost of \$9,000.

John Charles Norton of Bryn Mawr, is preparing plans for an apartment house to be erected at Haverford to cost \$20,00. Plans will be ready for bidders on October 15. He is also preparing plans for a stone garage 40 by 60 feet for George M. Chichester. Bids will be asked for the construction of his building in a short time.

Frank Thompson's house at 16 North Second Street in the borough of Darby, has been sold to a Philadelphia party, and the Taylor family will shortly move to the property at No. 22 North Second Street.

Settlement was made during the week by Tahlmon I. Brubaker for a plot of ground 150 by 275 feet on Baltimore Avenue, in the borough of Lansdowne. This property was recently purchased from the estate of the late Edward A. Price. The new owner will build a fine house on the lot, which is located at Runnymede Avenue.

Stacey Reeves & Sons have been awarded the contract to build a stable, garage and green house and make alterations to the house of T. M. Fitzgerald in the borough of Lansdowne. Work will be commenced at once.

William R Dougherty of Philadelphia, has been awarded the contract for the erection of the new school building in the borough of Norwood. It will be 46 by 73 feet and will be built for St. Gabriel's Roman Catholic Church. It will be constructed of stone, two stories high, tile roof, electric light, steam heat and hardwood floors.
