CHESTER TIMES – January 24, 1914 - DARBY TO HAVE BUILDING BOOM – Over Three Hundred Houses to be Erected in the Spring is the Report Given out by Builders

Unless all signs fail there will be a big building boom in the borough of Darby this spring, the statement being made by what is considered a reliable source that ground will shortly be broken for the erection of one hundred and twenty-five up-to-date dwellings. Builders some time ago predicted that with the building of the new Catholic Church other buildings would follow in quick succession, and this prediction is about to be verified. The new church will be a handsome structure and will cost, completed, about \$25,000. The ground for the combined church and school will be broken on March 25, according to the pastor, Rev. William A. Fitzgerald. The chapel will be located in the basement of the building and the other part of the structure will be used as a school.

It is also reliably stated that there will be an operation of some magnitude on Main Street, between Third and Fifth Streets, this land having been recently sold to a syndicate of Philadelphia builders. It is said that this operation will embrace two hundred houses. With these two large operations, there will be smaller operations of ix, eight and ten houses, in blocks in other parts of the borough.

Realty men at Lansdowne report bright prospects for the spring, as already a number of projects are underway for new dwellings.

At Boothwyn, Frank E. Griffith has purchased from 9. T. Harkness, a house, store and barn and outbuildings for a consideration of \$3000.

PERMITS GRANTED – There were bantwo permits granted during the week by Building Inspector T. T. Williams. He report building matters slow, but looks for a big boom with the advent of good weather.

Edward Todd took out a permit for the erection of a one-story frame building to be covered with iron in the rear of 2708 Vest Third Street.

The Harbinson, Walker Refractories' Company were granted a permit for the erection of a one-story brick bunking at the foot of Welsh Street. They operate what is known in this city as the Falette Brick Works. The building will be 11 by 11 feet, twelve feet high.

MORE HOUSES FOR FIRST WARD – Ex-City Controller William J. Oglesby, who has been a factor in the building development of Chester during the past few years, has decided to creet a number of two-story brick dwellings on Twenty-Second Street and Twenty-Third Steet next spring. The houses will be graced with neat front porches and will control all the modern conveniences.

The four houses being built by Joseph Arment at Twenty-Third Street and Edgmont Avenue are rapidly nearing completion. The dwellings are two stories in height and are constructed of brick. The walls of the houses were recently plastered by Frank Sheppard.

There promises to be a building boom in Brookhaven next spring. Among those who contemplate building residences of their own in that section are Albert F. Phillips, the gas fixture merchant of 525 Market Street and Fred M. Fairlamb, the letter carrier of 213 West Third Street. The dwellings will be of the bungalow design.

The nine stores and eighteen apartments erected at Seventh and New Market Streets by the Chester Realty and Investment Company will soon be ready for occupancy. The steam heating system has been installed and finishing touches are now being made to the interior of the structures.

NEW \$40,000 CHURCH – The new building committee of the Providence Avenue Methodist Episcopal Church expects to begin operation of the erection of the proposed new \$40,000 stone edifice next spring. The plans for the construction of an ornate building at the corner of Eighteenth Street and Providence Avenue have been adopted, but the contract will not be let until next month.

The old Chester Academy building at Broad and Potter Streets, have been extensively remodeled by William Lukens, who bought the property several months ago. Several additions have been made to the building which is being transformed into an up-todate apartment house.

OTHER OPERATIONS AND DEALS – Plans are in progress for the erection two-story brick store and shop at 870 Main Street, in the borough of Darby. The owner is W. E. Finegan. The building will have a slag roof. The heating and lighting at of the contract is reserved to be let by the owner. The architect is H. M. Pedrick.

The plans for the proposed new residence of Dr. M. Jacobsin the borough of Media, are being revised. This will be a frame structure, one and one-half stones high, 34 by 39 feet, shingle roof, electric lights and hot water heating. Bids will be asked just as soon as the plans are adopted.

A. J. Drexel Paul of Radnor is having plans prepared for a two-story stone tenement house, 20 by 50 feet with one wing, shingle roof, Not ar heat. The plans are almost ready for bids for the work.
